Northern Golf Juníor Age:

Please remember that in the Northern Golf District the age for juniors is 21 and under for boys and girls. Golf Southern Tasmania has come on board as well now with their junior events 21 and under for boys and girls

Unfortunately for this group of young golfers around the State, it is disappointing this has not yet been repeated at Golf Australia/Tasmania, Golf North West and SCGA.

Northern Golf Junior Championships:

Both years' junior events were held at the Prospect Vale Golf Club

The 2021 Northern Junior Girls Championship was won by Jorjah Bailey Launceston

The 2021 Northern Junior Boys Championship was won by Isaac Roberts Riverside

Golf Aust/Tas Juníor Matchplay.

Great to have this junior event back again in 2021 when Covid -19 played its part in cancelling the event in 2020, the first match was played at the Longford Golf Club on 1st October and the second match at the Pittwater Golf Club on 4th October In 2022 it was increased to play it 4 times in a single year, South won on 18th April at Longford 7 - 3, return match 22nd April at Pittwater a draw 5 - 5, round three 7th October North 6 - 4, final round 10th October at Pittwater was a draw 5 - 5 each, with South Juniors winning the event 21 games to North 19. What a fantastic event for our junior golfers.

2022 Northern Golf Student Championship:

Due to inclement weather this event was postponed until later in the year.

Betty Bradley Award - Junior Consistency: Gavan Griffin Award for most improved junior.

The Betty Bradley Consistency is played for each year during each school holiday stableford competitions throughout the year, the player with the best average score from the junior tournaments played during these events throughout the 2021 – 2022 also saw the introduction of 6-, 9- and 18-hole stableford to cater for beginners as well as juniors already playing golf regularly. It is very pleasing to see the number of junior boys and girls playing in these events again.

Koby Wegman won the 2021 Betty Bradley Award, 2022 Gavan Griffin has agreed to sponsor the most improved junior (thank you Gavan)

Northern Golf Junior Committee would like to take this opportunity to thank Frank Stone (Betty's son) for his continued financial support to Northern Golf Junior "Betty Bradley Award".

The Board of Northern Golf and Junior Committee Northern Golf expresses its appreciation to Richard Sattler for sponsoring the Northern Juniors boys and girls since 2008, providing the opportunity for junior boys and girls in the Northern Golf District each year to have a **free** game of golf at Barnbougle Lost Farm.

Mygolf Juníor League:

The full aim of the Mygolf Junior League is for the member golf clubs to own and run the MGJL. It is intended to get junior boys and girls from the Mygolf Junior program (run by the local PGA Professionals) onto the golf course and anticipate that a majority of junior's boys and girls will continue with golf into the future and join a golf club, but it can only happen with support from member clubs, if clubs don't own the Mygolf Junior League, then it will fall over. The only ones to suffer would be prospective boys and girls. The first 2022 competition was to be held in March 2022 was unfortunately cancelled due to very little interest from member clubs; the second session is arranged to be held in November and December, so come on member clubs and take ownership of this wonderful event that in time will only benefit your golf club.

All is in readiness for golf clubs to run the Spring MGJL program starting on Saturday 19th November 4pm at the Prospect Vale GC, Saturday 26th November 4pm, Mowbray GC Saturday 23rd November 4pm, Launceston GC, Saturday 10th December 4pm Riverside GC.

There is quite a lot of positive news with regards to junior girl's participation in Tasmania.

- 1. There were 434 female registrations for Mygolf during July 2021 to June 2022 period. This is 37% of the total (1166) Just over 1/3 of junior golfers in Mygolf programs in Tasmania are currently female. Nationally the rate is 31%.
- Australian Foundation Junior Girl Scholarship We are aiming to have 50 junior female golfers enrolled at 8 golf clubs in Tasmanian 2023, In Tasmania, there were 24 girls at 4 golf clubs. The scholarship is aimed at girls aged 10 - 16 is designed to foster a deep love of golf by creating strong bond between girls (aged 10 - 16) and their clubs/facility https;//www.australiangolffoundation.org.au/vision-2025
- 3. Golf Australia is offering all Mygolf centres grants of up to \$500. Which can be used for purchasing equipment to deliver programs as well as local area marketing or having people trained as community instructors.
- 4. Golf Australia encourages clubs to offer Mygolf Girls specific programs as a way of attracting new girls into golf and create a pathway for future AGF scholarship participants. https://.www.golf.org.au/mygolf/girls

Northern Golf Inc Notes to the Financial Statements For the Year ended 30 June 2022

The financial statements cover Northern Golf Inc as an individual entity. Northern Golf Inc is a not for profit Association incorporated in TAS under the Associations Incorporation Act 1964 ('the Act').

The functional and presentation currency of Northern Golf Inc is Australian dollars.

1. Basis of Preparation

In the opinion of the Committee of Management, the Association is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non current assets, financial assets and financial liabilities.

Significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

2. Summary of Significant Accounting Policies

(a) Property, Plant and Equipment

Plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment of losses.

Plant and equipment is depreciated on a straight line basis over the assets useful life to the Association, commencing when the asset is ready for use.

(b) Revenue and Other Income

Sale of Goods

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest Revenue

Interest is recognised using the effective interest method.

Dividend Revenue

Dividends are recognised when the entity's right to receive payment is established.

Rendering of Services

Revenue in relation to rendering of services is recognised depending on whether the outcome of the services can be estimated reliably. If the outcome can be estimated reliably then the stage of completion of the services

is used to determine the appropriate level of revenue to be recognised in the period.

If the outcome cannot be reliably estimated then revenue is recognised to the extent of expenses recognised that are recoverable.
